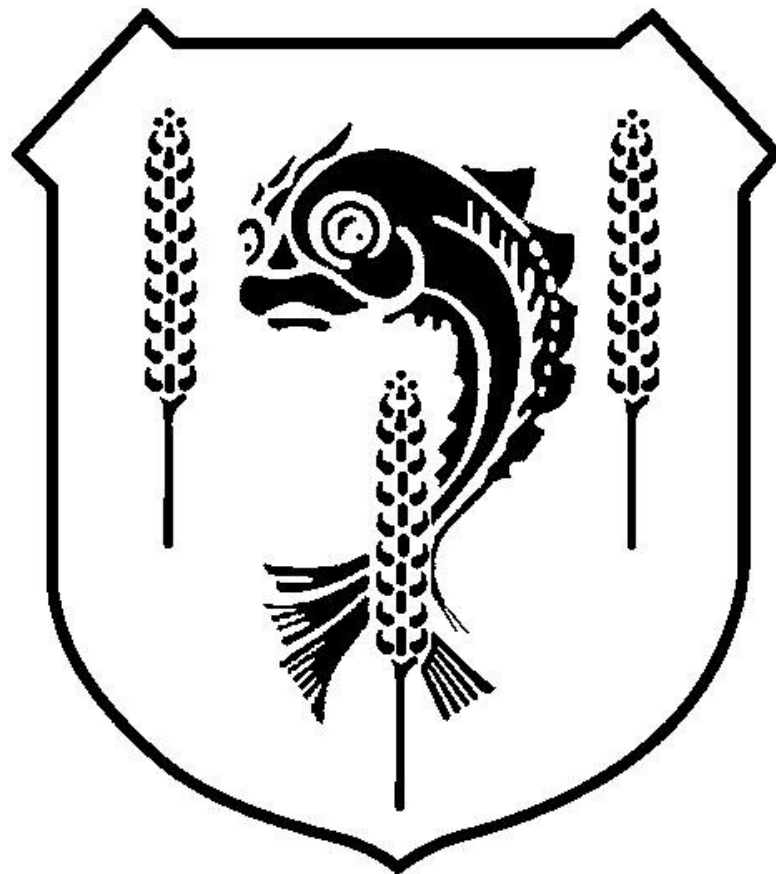


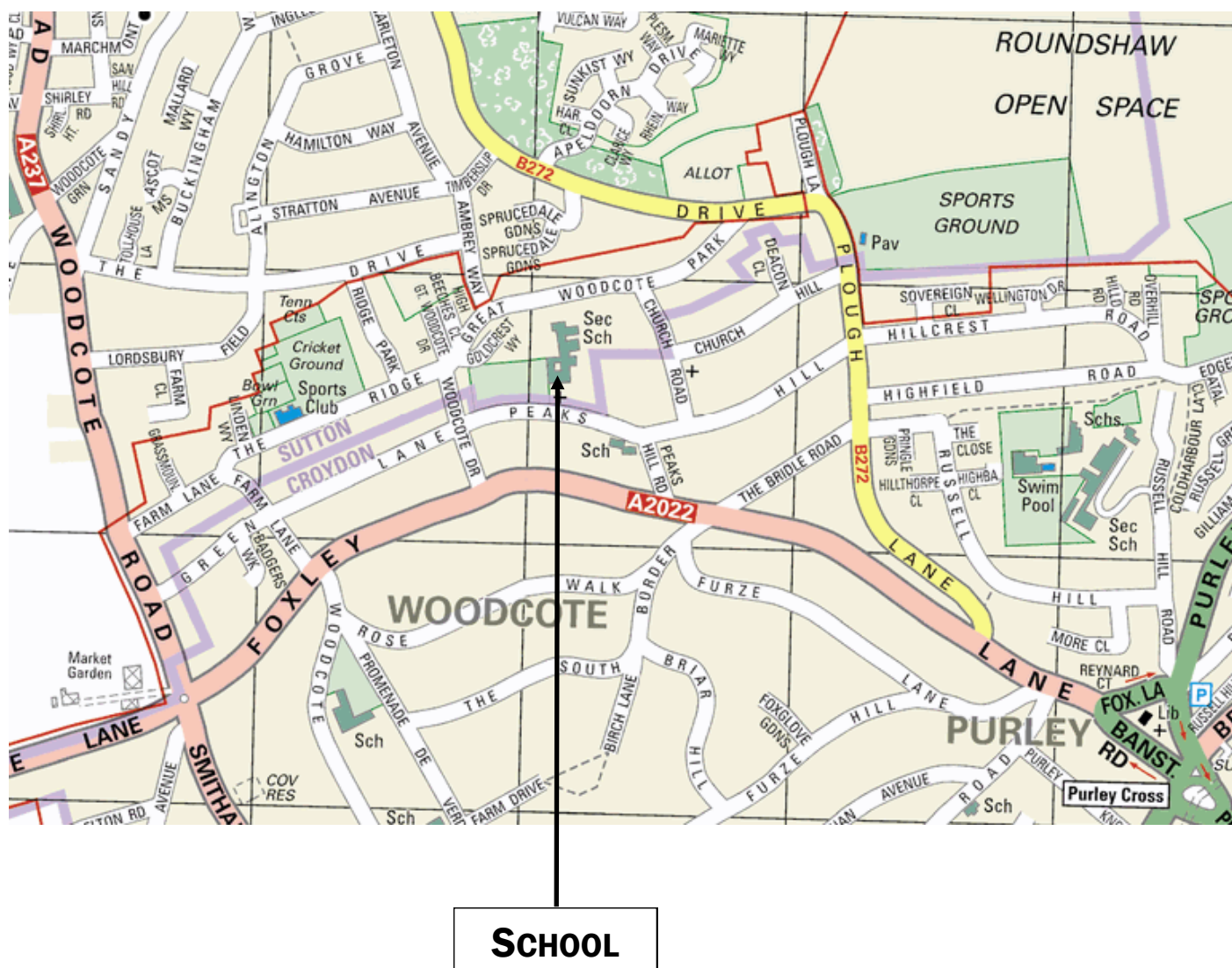

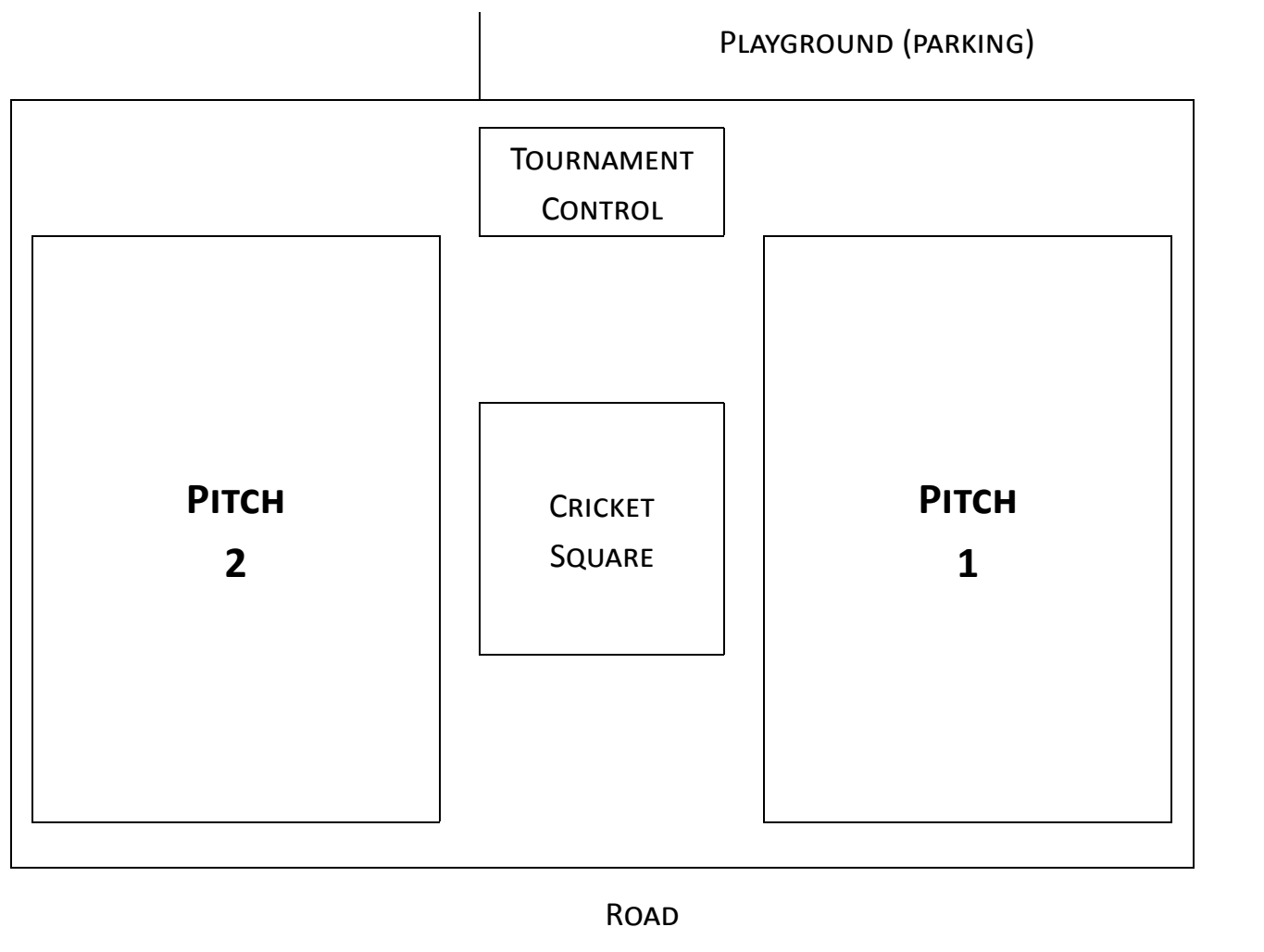

COMPETITION RULES

- 1** EACH SIDE SHALL CONSIST OF NINE PLAYERS, DRAWN FROM A SQUAD OF NO MORE THAN THIRTEEN. THERE ARE UNLIMITED ROLLING SUBS DURING STOPPAGES.
- 2** ALL GAMES, INCLUDING THE ADDITIONAL MATCHES, WILL BE OF SEVEN MINUTES DURATION EACH WAY. THERE WILL BE ONE MINUTE BETWEEN HALVES.
- 3** ALL LAWS OF THE GAME SHALL BE AS PER THE UNDER 12 RULES OF PLAY.
- 4** THE TEAMS WILL BE DIVIDED IN TO TWO POOLS, A & B, WITH FIVE SIDES IN EACH POOL. EACH SIDE WILL PLAY EACH OTHER IN THE POOL.
- 5** TWO POINTS WILL BE AWARDED FOR A WIN, ONE FOR A DRAW.
- 6** AT THE CONCLUSION OF THE GROUP STAGES, ALL TEAMS SHALL PLAY AN ADDITIONAL MATCH BASED ON WHERE THEY FINISH IN THEIR GROUP.
- 7** THE FINAL POSITIONS IN THE GROUP WILL BE DECIDED BY THE TOTAL NUMBER OF LEAGUE POINTS.
- 8** IN THE EVENT OF A TIE ON POINTS, THE POSITIONS WILL BE DECIDED BY:
 - A THE NUMBER OF TRIES SCORED OVER THE POOL STAGE
 - B THE NUMBER OF TRIES CONCEDED OVER THE POOL STAGE
 - C THE RESULT OF THE GAME BETWEEN THE 2 SIDES IN THE POOL STAGE
 - D THE TOSS OF A COIN
- 9** IN THE EVENT OF A TIE IN ANY OF THE ADDITIONAL MATCHES, THE RESULT WILL BE DECIDED ON A 'SUDDEN-DEATH' BASIS, I.E. THE FIRST SIDE TO SCORE ("GOLDEN POINT"), UP TO A MAXIMUM OF FIVE MINUTES. IF NEITHER TEAM SCORES, THE MATCH SHALL BE DECLARED A DRAW.
- 10** AS PER RFU DIRECTIVES, THE TEAM THAT WINS THE FINAL ADDITIONAL MATCH WILL NOT BE KNOWN AS "WINNERS OF THE TOURNAMENT". HOWEVER, THEY WILL RECEIVE A TROPHY AND MEDALS IN RECOGNITION OF THEIR EFFORTS - NOT THE FACT THAT THEY WON THE "FINAL" MATCH.
